I further RELEASE and DISCHARGE the above said entities and persons from any and all actions, causes of action, damages, demands, injuries and liabilities of any nature, including reasonable attorney's fees and interest, arising out of or in any manner connected with their involvement with my participation in conditions and hazards which may occur whether they now be known or unknown. Being fully aware of the risks, conditions, and hazards of bicycle riding. I HEREBY AGREE TO WAIVE, RELEASE and DISCHARGE any and all claims for damages, personal injury, property or entity mentioned above whether or not such injury and damage was foreseeable. I further agree to forever hold HARMLESS AND INDEMNIFY all persons and entities identified above, generally or specifically, for any and all claims brought against them from any and all liability for personal injury, property damage, and/or death resulting in any way from my participation in the 2007 Yockatomac Trek.
